Introduction

I refer to the Notice dated 29 September 2006 ("the Notice") submitted by Woodside Energy Ltd ("the Landowner") to the Aboriginal Cultural Material Committee ("ACMC") pursuant to section 18(2) of the *Aboriginal Heritage Act 1972* ("AHA").

The Notice advised that you require to use the land described in Schedule 1 of the Notice as Lot 572 on Deposited Plan 28209 (Industrial Site B) ("the Land") for the purpose described in Schedule 2 of the Notice as development and operation of an LNG Plant and all associated infrastructure and facilities ("the Purpose").

Consent

In accordance with my powers under section 18(3) of the AHA and following consideration of recommendations from the ACMC, I hereby grant consent to the use of the Land for the Purpose, subject to the conditions set out below.

I am advised that, based on current knowledge, the Purpose may impact upon 193 Aboriginal sites within the meaning of section 5 of the AHA ("Sites") on the Land. The Sites are listed at Annexure 1 to this letter.

Conditions of Consent

That the Landowner:

1. Preserve *in situ* Sites DIA 9254 (pecked humans), DIA 9255 (The Thylacines), DIA 23413 (WPB-033), DIA 23414 (WPB-034), DIA 23416 (WPB-036), DIA 23481 (PB-073), DIA 23427 (WPB-052), DIA 23537 (WPB-AG-46), DIA 23408 (WPB-028), DIA 23402 (WPB-022), DIA 23431 (WPB-054), DIA 23379 (WPB-106), DIA 23394 (WPB-014), DIA 23400 (WPB-020), DIA 23401 (WPB-021), DIA 23404 (WPB-024), DIA 23406 (WPB-026), DIA 23337 (WPB-065), DIA 23340 (WPB-068), DIA 23534 (WPB-AG-43), DIA 23535 (WPB-AG-44), DIA 23415 (WPB-035), DIA 23688 (WGTO PB 43), DIA 23716 (WGTO PB 107) and DIA 23352 (WPB-80).

2. In addition to condition 1 above, use best endeavours to leave all Sites on the Land *in situ*.

Special effort must be made in respect of the following Sites: DIA 9252 (Haul Road Valley East), DIA 9278 (Eagle's Nest), DIA 10557 (Gas Pipeline), DIA 23440 (WPB-AG-33), DIA 23382 (WPB-02), DIA 23343 (WPB-71) and DIA 23740 (WGTO PB 173).

3. Where it is not possible to comply with Condition 2, use best endeavours to record, salvage and relocate Sites, using the processes set out in Conditions 5, 6, 7 and 8 below.
4. Use best endeavours to minimise disturbance to the three major valleys on the Land (including Surveyors Valley) during all or any ground disturbing activity for or associated with the Purpose, including, but not limited to, the construction of infrastructure and/or the salvage and relocation of material from Sites on the Land ("the Ground Disturbing Works").
5. Collect and provide to the Department of Indigenous Affairs ("DIA") prior to the Ground Disturbing Works:
 - a) Details of the location of each Site on the Land *in situ*, including a map of the location;
 - b) A description of the nature and characteristics of the Site;
 - c) A photograph of the Site; and
 - d) Any gender or cultural restrictions applying to the Site.
6. a) Consult with representatives from the Yaburarra and Coastal Mardudhunera groups, and the Ngarluma and Injibarndi groups, and the Wong-Goo-Tt-Oo group ("the Groups"), and DIA to prepare a Cultural Heritage Management Plan ("CHMP") based on but not limited to the matters contained in clause 9

of the Heads of Agreement dated 30 May 2006 and the recommendations contained in the heritage survey reports provided in support of the Notice.

- b) Include in the CHMP a commitment that the Landowner provide assistance in the management of all and any material salvaged from Sites in accordance with Condition 5 above ("the Salvaged Material") in accordance with the wishes of the Groups. Such assistance must include the provision of suitable facilities for the short and long-term storage of the Salvaged Material in accordance with the wishes of the Groups.
7. Conduct a relocation audit of the Land ("the Relocation Audit") prior to the commencement of the Ground Disturbing Works to:
 - a) Determine the number of Sites to be relocated; and
 - b) Develop, in respect of each Site to be relocated, a work plan detailing how the relocation is to proceed.
 8. Provide a copy of the Relocation Audit to DIA and a copy of (at least) a draft of the CHMP prior to the commencement of the Ground Disturbing Works.
 9. In consultation with the Groups (and as a component of the CHMP) engage an agreed number of appropriately experienced representatives from the Groups ("the Consultants") to monitor the Ground Disturbing Works in the following situations:
 - a) Where any heritage consultant engaged in respect of the Purpose has indicated that there is a likelihood of finding objects within the meaning of section 6 of the AHA ("Objects") during the Ground Disturbing Works; and
 - b) Where the Ground Disturbing Works will impact directly or indirectly on a Site.
 10. In consultation with the Consultants, appoint a suitably qualified archaeologist ("the Archaeologist") if any Objects are found during the Ground Disturbing Works, such Archaeologist to assist the Consultants to make decisions about salvaging the Objects and about future monitoring requirements in respect of the Ground Disturbing Works.
 11. Undertake fieldwork to verify the location of all Sites recorded in the heritage survey conducted with representatives of the Wong-Goo-Tt-Oo group, including assessment of archaeological significance.
 12. Immediately cease all Works if skeletal remains ("Remains") are found and report the matter to the Western Australia Police Service and local DIA office. Where it is determined that the Remains are Aboriginal in origin and not a police matter, they must remain *in situ* until a decision is made about how to proceed in respect of the Remains at an on-site meeting with a DIA representative, representatives of the

Groups and an Archaeologist. The Landowner must at its expense manage the Remains in accordance with the wishes of the Groups and report the whereabouts of the Remains to the Anthropology Department of the Western Australian Museum and DIA.

13. Provide to the Registrar of Aboriginal Sites ("the Registrar") annually, or at the completion of the Purpose if the Purpose is completed within one year, a written report advising the Registrar whether and to what extent the Purpose has impacted on all or any Sites or Objects that may be located on the Land, including a detailed description of:
- a) whether such Sites or Objects have been partially or entirely impacted by the Purpose;
 - b) the level, type and effect of any such impact (including, where possible, the provision of photographs taken during and after the impact);
 - c) if Objects are removed from the Land, including through salvage, each and every such removed or salvaged Object (including, where appropriate, a photo of the Object), when and how it was removed or salvaged, where it was removed or salvaged from, where it has been relocated to (including if to a Cultural Centre or Keeping Place), who was present at the removal or salvage, and the type and reasons for any restriction on disclosure of the place to which the Object has been relocated.

Failure to comply with these conditions may constitute an offence under section 55 of the AHA. DIA carries out routine checks on compliance with conditions of ministerial consents.

Requests and Advice

The Landowner is requested to give due consideration to requests made by Aboriginal people during consultation about the Purpose regarding the protection of Aboriginal heritage and the recognition of Aboriginal culture and history.

In addition, the Landowner should ensure that all persons employed or engaged in respect of the Purpose and the Works are made aware of their obligations under the AHA, including by inserting into all and any relevant contracts, project plans, scopes of works, tenders and other similar documents a requirement that such persons be provided with a copy of a document prepared by DIA and entitled "Advice to Developers" and/or an electronic copy of a document prepared by DIA and the Department of Housing and Works and entitled "the Aboriginal Heritage Procedures Manual", both of which can be found at:

Other Matters

This consent can be relied upon by only the Landowner. Any subsequent 'owner' of the land within the meaning of the AHA must make its own application under the AHA.

Where the Landowner is aggrieved by a decision made under section 18(3) of the AHA the Landowner may apply to the State Administrative Tribunal for a review of the decision.

Extracts from section 17 and section 55 of the AHA and relevant sections of the *Aboriginal Heritage Regulations 1974* are attached for your information.
